2012 Annual Meeting highlights

ocmulgee EMC (OEMC) hosted its 74th Annual Meeting of Members on Wednesday, Oct. 10, 2012, at the Eastman-Dodge Recreation Department Gymnasium in Eastman.

A total of 812 Members registered for the meeting and enjoyed entertainment by Ray and Wanelle and The Phoenix Band.

Rev. Mike Grenade gave the invocation to open the meeting. Board President Barry Martin welcomed all Members and guests. Directors Algie Jones and Billy Hartley were unopposed for their board seats, while Blake Rowland was challenged by Rocky Stuckey. Rowland was re-elected, receiving 56 percent of the votes cast. The membership voted down an amendment to the Bylaws of Ocmulgee EMC for a minority-only slot on the board, with 62 percent against it.

In the Treasurer's Report, Martin informed Members about the positive growth of Ocmulgee EMC. In the past 30 years, he said, OEMC's investment per Member has risen from \$1,310 to \$4,220, while the number of meters has risen from 7,237 to 11,812. During that same time, the miles of lines energized have grown from 1,279 to 1,997.

General Manager W. H. Peacock addressed Members about challenges faced by the cooperative in 2011-2012. These included construction of a large number of three-phase-line extensions to meet farmer demand for new irrigation pumps. Line crews had to work overtime to keep up with this demand, plus do

normal construction and maintenance.

Another challenge to OEMC was a summer weather pattern that produced several record hot/high-demand days, but allowed overall energy sales to fall by 8 percent from last year. This created a real challenge to the co-op because the wholesale power purchase price is based on maximum demand days.

Peacock stated that fortunately, the co-op refinanced several loans at lower interest rates to improve cash flow. An engineering study was also done, and recommendations to add equipment to the electrical distribution system and a rebalance of

> the load on major threephase feeders are already improving the efficiency of the system and saving money. This will continue to increase revenue in the future.

The general manager also mentioned the progress that the co-op has made in improving its

Georgia Agricultural Sales Tax Exemption guidelines

n 2012, Gov. Nathan Deal signed House Bill 386, which included a number of changes to Georgia's tax system. These changes, which will take effect Jan. 1, 2013, include:

- The nullification of the existing
 Agricultural Certificate of Exemption,
 ST-A1, as a valid state form;
- The replacement of ST-A1 with a tax exemption certificate issued yearly by the Department of Agriculture to each qualified agricultural producer; and
- The necessity of the agricultural producer to apply annually to the
 Department of Agriculture for the tax
 exemption certificate at a small fee.

Effective Jan. 1, 2013, no accounts will be tax exempt, due to House Bill 386. For your accounts to be tax exempt from that date forward, you will need to provide Ocmulgee EMC with a copy of your new tax exemption certificate issued by the Department of Agriculture. You will also need to renew this annually. For any account to be tax exempt on Jan. 1, 2013, we will need your new tax exemption form by Dec. 31, 2012.

You will need to list each account that will receive the exemption on the GATE addendum form. Bring this sheet with you when you bring in your exemption certificate. If you set up new accounts during the calendar year, you will need to inform us when the account is set up that it needs to be tax exempt. If you fail to do that, and tax is charged and collected on those accounts, you will need to request a refund from the state. Ocmulgee EMC is not allowed to refund collected sales tax.

Per the Department of Agriculture, applications for the exemption certificate will be accepted via their website at www.agr.georgia.gov.

Ili Belflower and Joseph Rozar, representing the Bleckley County FFA and Hawkinsville High FFA, respectively, recently competed in the Area III EMC /FFA Career Development event. This very difficult competition has three parts, the most important of which is the wiring problem. Each student must acquire the correct materials and wire a problem consisting of panel disconnects, lights, switches and receptacles. They must know how to determine the correct breaker size, conductor size and count, and box sizes for the given problem. Then they must have the skill to actually wire the problem in a predetermined amount of time and make it work correctly.

In the problem-solving segment, the student uses code and hand-books, such as the National Electrical Code, to answer difficult questions about electrical wiring codes and references. The final part of the contest is the speech/demonstration portion, in which the student stands before a panel of judges and explains the process of wiring a problem.

A special congratulations to Eli Belflower, the winner of the 2012 Area III contest! Eli will compete in the statewide competition in Covington in January.

These young men and their agriculture education instructors (Walt Parks at Bleckley County and Jody Cravey at Hawkinsville) are to be commended. Tom Cranford, ag instructor at Dodge County High, is a great supporter and participant, but did not have a student competing this year.


